3 meritorious and should be granted to honor the wishes of the deceased.

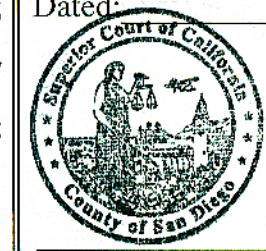
5 THEREFORE, IT IS ORDERED THAT the motion of Plaintiff is GRANTED.

6 It is further ORDERED that:

- 8 1. Loren Latker shall be allowed to move the Cremated remains of PEARL EUGENIA
9 CHANDLER from the storage facility at Cypress View Mausoleum to Mount Hope
10 Cemetery;
- 11 2. The Cremains shall be interred near or at the grave-site or under the grave-marker
12 where RAYMOND THORNTON CHANDLER, famous author, is buried, either
13 above ground or below the marker of RAYMOND THORNTON CHANDLER;
- 14 3. PEARL EUGENIA CHANDLER shall be interred (at Mount Hope Cemetery) in a
15 dignified and professional way, according to the standards typically used by a
16 licensed certified California cemetery pursuant to California Health & Safety code
17 requirements;
- 18 4. CYPRESS VIEW MAUSOLEUM and MOUNT HOPE CEMETERY shall cooperate
19 with the Orders set forth herein and shall assist Plaintiff by executing any necessary
20 documentation and/or permits in order to satisfy these Orders;
- 21 5. Plaintiff, Loren Latker, shall bear all costs, unless otherwise covered by the
22 municipalities in the regular course of business.
