

Codicil

I, Raymond Thornton Dendler,
at present a resident of La Jolla,
California, hereby declare this to
be a codicil to my will dated May
20th 1958, and by this present I declare
that the beneficiary under the said
will shall be changed and shall
become Mrs. Helga Mary Greene of
1A South Eaton Place, London, England.

I name the said Helga Mary Greene
my sole heir and executrix, as also
my sole literary agent on heretofore agreed
terms. For the purpose of protecting my
copyrights within the United States
she shall have the right and duty to
join with herself as co-executor any
person, firm or organization legally
proper for that purpose.

In the case of the death of the said
Helga Mary Greene prior to my death

 I name as my heirs, subject to trustee-
 ship as hereinafter stated, Vincent Fracasse
 and Rachel Anne Fracasse, children of
 Mrs. Jean Fracasse, all now resident at
 1418 Derry Lanes Road, La Jolla, California.

As Executors and Trustees of my Will,
 in the event of the pre-decease of Helga
 Mary Greene, I name Michael Francis
 Gilbert, Esq., of 52nd Street, Lincoln's
 Inn, London W.C. 2, England, and
 Graham Carleton Greene, Esq., of 36 Leinster
 Gardens, London W. 2, England. The said
 Executors and Trustees shall have the
 power, without restriction to disburse from
 my estate, both capital and income, what sum
 or sums they deem proper for the education and
 welfare of the Fracasse children named
 above, and upon the coming of age of Vincent
 Fracasse the corpus of my estate shall
 be divided equally between him and his
 sister. If either child should die before
 this distribution, then the entire estate shall
 go to the other. If both should die in the life

period of the Trusteeship, then the Corpus
of the estate shall be divided equally
between my two named Executors and
Trustees. The said Executors shall join
with themselves a Co-Executor of their
choice for the purpose of protecting my
property and copy rights within the United
States of America, and shall allow him
whatever fee is proper. Michael Francis
Gilbert, being a practicing Solicitor, shall
at all times be entitled to his regular
fee for services performed. Graham Carleton
Jr shall receive no fee, but shall
receive anything of my personal effects he
desires.

Both Executors and Trustees shall have
the power of substitution, but if this power be
exercised by either, then the other shall
become my residual heir, and if it be
exercised by both, then the Crime Writers
Association of England shall become my
residual heir.

My Executors shall employ a literary
agent to administer my literary properties
and shall receive the income therefrom -
