I DEVISE AND BEQUEATH all my real and personal estate whatsoever and wheresoever (including all entailed property of which I have power to dispose by Will) to JEAN VANDOUR FRACASSE now known by her maiden name JEAN VANDOUR DAVIS (hereinafter called "Jean Vandour Davis") absolutely if she shall survive me by the space of one calendar month and I appoint Jean Vandour Davis to be sole Executrix of this my Will \_\_\_\_\_

If Jean Vandour Davis shall fail to survive me by the space of one calendar month then the following clauses namely Clauses 2 to 9 inclusive shall be substituted for Clause 1 of this my Will and shall apply in lieu thereof \_\_\_\_\_

2. I APPOINT HELGA GREENE of 61 Eaton Mews West (S.W.1) in the County of London and MICHAEL FRANCIS GILBERT of 5 New Square Lincoln's in the said County Solicitor to be the Executors and Trustees of this my Will and they or other the Trustees or Trustee for the time being hereof are hereinafter called "my Trustees" \_\_\_\_\_

3. I DEVISE AND BEQUEATH all the real and personal estate not heretby or by any Codicil hereto otherwise effectually disposed of and which I can dispose of by Will in any manner I think proper either as being beneficially entitled thereto or under any general power (including any property in which I may have at my death an entailed interest in possession) unto my Trustees UPON TRUST that my Trustees shall sell the said real estate (including chattels real) and sell call

MY TRUSTEES shall out of the money to arise from the ~~sale calling in and conversion of my said real and personal~~ estate and out of my ready money pay my funeral and testamentary expenses and debts and pay or provide for the legacies and annuities hereby or by any Codicil hereto bequeathed so that all such legacies and annuities shall be paid primarily out of my personal estate and shall invest or lay out the residue of the said money in their names or under their control in or upon any of the investments or property hereby authorized with power at their discretion to vary or transpose any investments or property for or into others of any nature hereby authorized \_\_\_\_\_

5. I DECLARE that my Trustees shall stand possessed of the investments and property hereby directed to be made or authorized to be retained (hereinafter called the "Trust Fund") upon trust for Vincent Fracasse (son of Jean Vandour Davis) provided he shall attain the age of twenty-one years and Sybil Fracasse (daughter of Jean Vandour Davis) provided she shall attain the age of twenty-one years or marry under that age \_\_\_\_\_

6. MY TRUSTEES may (notwithstanding any trusts hereinbefore contained) postpone the sale calling in and conversion of any part of my real and personal estate for such period as they may think proper and further may retain permanently any part of my real and personal estate in its existing condition \_\_\_\_\_

7. TRUST MONIES may be invested or laid out in the purchase of or at interest upon the security of such stocks funds shares securities or other investments or property (real or personal) of whatsoever nature and wheresoever

situations and whether involving liability or not and whether producing income or not or upon such personal credit with or without security as my Trustees shall in their absolute discretion think fit including the purchase of any real or leasehold property as a residence for any person or persons for the time being interested in the income of such moneys and the purchase of chattels for the use of such person or persons TO THE INTENT that my Trustees shall have the same full and unrestricted powers of investing and transposing investments and laying out moneys in all respects as if they were absolutely entitled thereto beneficially and in the professed exercise of this power my Trustees shall not be liable for any loss to the trust premises arising from any investment or purchase made in good faith \_\_\_\_\_

8. THE provisions of Section 31 and Section 32 of the Trustee Act 1925 shall apply hereto subject nevertheless to the following variations:- \_\_\_\_\_

(a) the words "may in all circumstances be reasonable" shall be omitted from paragraph (1) of sub-section (1) of Section 31 and there shall be substituted the words "my Trustees shall in their absolute discretion think fit" and the proviso at the end of sub-section (1) shall be omitted \_\_\_\_\_

(b) Proviso (a) to Section 32 (1) shall be omitted and the words "advancement maintenance education or benefit" shall be substituted for the words "advancement or benefit" in that Section \_\_\_\_\_

9. I would wish Jean Vandour Davis or my Trustees (as the case may be) to employ the services of the said Helga Greene in the management and sale of all literary property
